**"TUX & TENNIES" PARTY:** All participants are invited to the 8th Annual Tux & Tennies Party at 6:30pm on Saturday, September 11th at the Newport Beach Tennis Club, featuring dinner, casino night and dancing. Guests are encouraged to dress in a combination of Tux and Tennies attire. Additional Party guests are \$50 per person.

**ENTRIES:** Cost will be \$50 per person/\$100 per team for Men's, Women's Doubles/Singles entries, \$100 per team for Mixed Doubles entries. Entries will not be accepted without full payment of fees. Refer to entry form for payment options. You can also register online at www.grandprixtennis.com

**CLASSIFICATION:** Players are limited to two events, same division. All players must play at their highest ability level. **WARNING:** Once the first round begins, the tournament committee reserves the right to disqualify any player or team, regardless of their NTRP or club affiliated rating, that is determined to be over-qualified for the event entered, with forfeiture of entry fee. **PLAYERS WHO HAVE NOT REACHED THEIR 18TH BIRTHDAY MUST PLAY IN THE OPEN OR 6.0 DIVISION.** Winners of 3.0 - 5.0 divisions may defend title for one year providing the players ratings have not increased during the year. All winners of previous year's tournament are entitled to move up to next highest division and receive a free entry. Pro-Junior teams must be comprised of one adult tennis professional and one junior under the age of 18.

**CONSOLATION DIVISION:** There will be a consolation draw in divisions 3.5 - 6.0, provided there are more than 4 teams in division.

**SPECIAL AWARDS:**

- 4.0 Mixed Doubles: The Earl Philpot Memorial Trophy
- 6.0 Men's Doubles: The Rick Foster Memorial Trophy
- Umpiring/Leadership: The Bill Ruhle Umpiring/Leadership Award

**FORMAT:** All matches will be the best two of three tiebreak sets, regular scoring and 12-point tiebreak at six games all. USTA rules will govern play and all players agree to abide by the decisions of the Tournament Chariman, Tournament Director and/or Referee in all matters relating to play or rescheduling of matches, if necessary.

**LOCATIONS:** All preliminary rounds will be played at local tennis clubs in Orange County with the semi and final rounds to be played at the Newport Beach Tennis Club.

**SCHEDULING:** PROBLEM PLAYERS WILL NOT BE ACCOMMODATED. ENTRANTS MUST BE AVAILABLE TO PLAY AS SCHEDULED. NO REFUNDS WILL BE MADE DUE TO SCHEDULING CONFLICTS.

**DEFAULT:** All players are encouraged to report/check-in at the site tournament desk at least 15 minutes prior to match time. USTA rules on "Lateness for Match" will be followed. Players may be defaulted 15 minutes after match is called. Only the Tournament Director and/or Referee can declare a default.

**ORANGE COUNTY GRAND PRIX:** All participants will receive Orange County Grand Prix Series points.

**INCLEMENT WEATHER:** In case of questionable or inclement weather, the tournament committee reserves the right to reschedule match times as needed. All players are advised that the rescheduled matches may include tournament participation on or during subsequent weekend(s). It is the player's responsibility to contact the tournament for rescheduled match times.

**DRESS CODE:** Proper tennis attire dictated by club regulations. Some facilities may require collared shirts for men.

**AWARDS:** Winners & Finalists will receive trophies and/or awards on September 12, 2010, at the Newport Beach Tennis Club.

**PRIZE MONEY:** A minimum of 80% of all entry fees per open divisions shall be paid out in prize money to winners/finalists. If there are 16 entries (teams) or more per division, payout will extend to semi-finalists.

**DEADLINE:** All entries must be received with full payment via mail, fax or on-line service before midnight, August 22, 2010.
